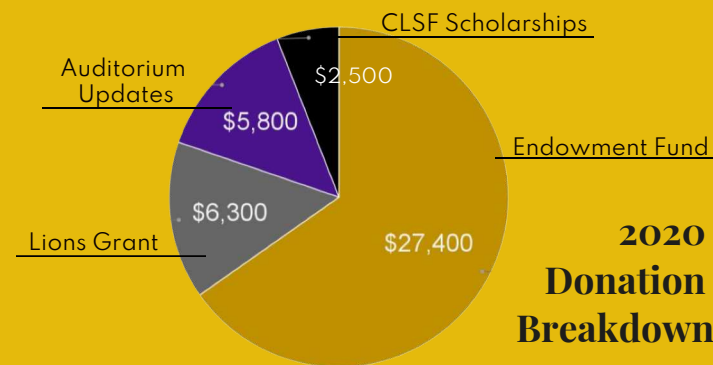
MISSION STATEMENT
